a. Motion by Vice Chair Davis and Seconded by Secretary Cowley to approve the proposed General Tax Rate at 0.2695 per \$100 of assessed valuation. The proposed tax would be \$1,132,602,36 for the 2021-2022 fiscal year of General Revenue Budget. This is a total is computed from the Current year tax rate ceiling "Maximum legal rate to comply with Missouri laws Political Subdivisions tax rate 0.4509 less 50% of prior year sales tax 0.1814 equaling a tax rate to be levied of 0.2695 as above. Multiply 0.002695 by the districts assessed valuation equals revenue of \$1,132,602.36. Roll Call Vote:

This is a total is computed from the Current year tax rate ceiling "Maximum legal rate to comply with Missouri laws Political Subdivisions tax line (F) of the Proforma from the state auditors. Multiply 0.000455 by the districts assessed valuation of \$420,260,617 equals revenue of \$191,218.58.
